

PRE TENDER MEETING FOR LAND DEVELOPMENT, TOPOGRAPHICAL & CONTOUR SURVEY WORKS



PROPOSED WWTP AND ZLD PLANT GAIL PATA

- The Bidder must have completed / executed Contract / Work(s) of “Similar Work” within last 07 (Seven) years period reckoned from bid due date & its Completed / Executed value as per below :
Minimum 01 Number of WO /LOA /Contract having minimum executed /completed value of Rs. **12.04** Crores

OR

Minimum 02 Numbers of WO(s) /LOA(s) /Contract(s) having minimum executed /completed value of Rs. **7.52** Crores against each WO /LOA /Contract

OR

Minimum 03 Numbers of WO(s) /LOA(s) /Contract(s) having minimum executed /completed value of Rs. **6.02** Crores against each WO /LOA /Contract.

- **Definition of Similar Work:**

Land Development along with experience of Work Permit System (Hot & Cold) in the field of Oil / Gas / Refinery / Power / Petrochemicals / Fertilizers projects.

- In case the bidder has executed Composite Works which includes the qualifying work(s) as per the above definition of “Similar Work”, then the value of such qualifying work(s) out of the total value of Composite Works shall be considered for the purpose of qualification.
- Bids from consortium / Joint Venture shall not be accepted.

- Experience of bidder acquired as a sub-contractor can be accepted against submission of certificate from end user by such bidder along with other qualifying documents such as Completion Certificate, Work Order, etc.
- Execution certificate (issued by the end user/owner/authorized consultant) submitted by a bidder against work contracts can also be considered in place of completion certificate for meeting the stipulated experience criteria provided that the asset for which the said execution certificate has been issued is ready for commercial use.
- A Job executed by a Bidder for its own plant/ project cannot be considered as experience for the purpose of meeting BEC of this Tender Document. However, jobs executed for Subsidiary/Fellow subsidiary / Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/Fellow subsidiary/ Holding company. Such Bidders to submit these documents in addition to the documents specified to meet BEC.
- While evaluating the Bids, Bidder's past experience as a leader or member of a Consortium/JV shall be considered acceptable, provided his scope in that Consortium/JV meets the requirement stipulated in the subject BEC above. In case, the PTR of Consortium/JV experience submitted by the Bidder meets the similar work without indicating the division of scope of work in terms of specific activities and associated value of work between the Consortium/JV members, but only the division of scope in terms of percentage share is indicated, in such case the completed value shall be arrived at after considering percentage share of each member, for the purpose of BEC evaluation.

➤ **Annual Turnover**

Average Annual Financial Turnover of the bidder as per the audited financial results during preceding (3) three financial years shall be **approx. INR 7.52 Crore.**

➤ **Net worth**

Net worth of the bidder should be positive for the financial year ending 31.03.2023.

➤ **Working Capital**

Minimum Working Capital of the bidder as per the last audited annual financial statement of FY 2022-23 should be **approx. INR 1.5 Crore.**

“Working Capital should be current assets minus current liabilities”

- Bidder must not be **black listed** by any government department/public sector undertaking/co-operative Unit.
- Bidder must not be delisted / on Negative list by any government department/public sector undertaking/co-operative Unit in the last two years, as on date of participating in the tender.
- Bidder must not be on the **Holiday list** of GAIL.

- Copy of complete work order along with its Schedule of Rates (SOR) & Special Conditions of Contract (SCC)/Scope of Work (SOW) issued by the End User / Owner/ Authorized Consultant of End User or Owner.
- Completion Certificate / Execution Certificate issued by the End User / Owner (or their consultant who has been duly authorized by them to issue such certificate) only after completion/execution of work in all aspect.
- The Completion Certificate / Execution Certificate must contain the reference number of work order, actual date of completion / execution of work, executed / completion value etc.
- Only documents (Work Order, Completion certificate, execution certificate etc.) which have been referred/ specified in the unpriced bid, shall be considered in reply to queries (if any) during evaluation of Bids.

- Duly Certified Financial Capability in prescribed Format by Chartered Accountant with UDIN.
- Copy of complete Audited Annual Financial Statement of three (3) preceding Financial Year(s).

Note:

- If the bidder's working capital is negative or inadequate, the bidder shall submit a letter from their bank having net worth not less than Rs.1.5 crores, confirming the availability of line of credit for the amount mentioned in clause above.
- **Annual Turnover:** In case the tenders having the due date for submission of bid up to 30th September of the relevant financial year, and audited financial results of the immediate 3 preceding financial years are not available, the bidder has an option to submit the audited financial results of the 3 years immediately prior to that. Wherever the closing date of the bid is after 30th September of the relevant financial year, bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years. However, in case bidder is meeting the Annual Turnover criteria of BEC based on Audited Financial Statement of any one of the preceding 3 financial years, the same shall suffice.

Note:

- **Net Worth/Working Capital:** In case the tenders having the due date for submission of bid up to 30th September of the relevant financial year, and audited financial results of the immediate preceding financial year is not available, in such case the audited financial results of the year immediately prior to that year will be considered as last financial year for Net worth/ Working Capital calculation. Wherever the closing date of the bid is after 30th September of the relevant financial year, Bidder has to compulsorily submit the audited financial results for the immediate preceding financial year

➤ **Technical Criteria of BEC:**

- All documents in support of Technical Criteria of BEC to be furnished by the Bidder shall necessarily be duly certified/ attested by Chartered Engineer and Notary Public with legible stamp.

➤ **Financial Criteria of BEC:**

- Bidder shall submit “Details of financial capability of Bidder” in prescribed format duly signed and stamped by a Chartered Accountant.

Further, copy of audited annual financial statements submitted in bid shall be duly certified/ attested by Notary Public with legible stamp.

- Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. For details of competent authority refer to Annexure I of Order (Public Procurement No. 1) dated 23.07.2020.
- Further the above will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects. Updated lists of countries to which lines of credit have been extended or in which development projects are undertaken are given in the website of the Ministry of External Affairs, Govt. of India.

Note: Order (Public Procurement No. 1) dated 23.07.2020, Order (Public Procurement No. 2) dated 23.07.2020 and Order (Public Procurement No. 3) dated 24.07.2020, Department of Expenditure, Ministry of Finance, Govt. of India refers. The same are available at website <https://doe.gov.in/procurement-policy-divisions>.

- Bidder should have minimum prescribed domestic value addition requirement in line with the Domestically Manufactured Iron & Steel Policy (DMI&SP) for the Iron & Steel products involved in execution of the contract. Bidder shall submit affidavit from the domestic manufacturers of such Iron & Steel products.
- A bidder who is not manufacturer of Iron & Steel product and is unable to submit the affidavit from domestic manufacturers at bidding stage, such bidder can submit the affidavit issued by domestic manufacturers after placement of order. In this case bidder along with his bid shall submit an undertaking on the letter head.
- If a bidder does not submit above affidavit/ undertaking as per format, the offer of bidder shall be rejected.

- Being Domestic Tender only Class-I and Class-II local supplier are eligible to quote for the subject tender. (Non-Local supplier are not eligible to quoted for the subject tender).

However, purchase preference to only Class-I local supplier shall be applicable.

- Relevant documents shall be submitted by bidders in support of their claim being Class-I or Class-II local supplier in line with the Terms and Conditions and requirement of the bidding document.
